Parent Volunteer Positions: *After School Sports* at SCM are parent-run organizations that require each family to attend the **mandatory meeting on Tuesday, November 8th @ 5:00-5:45** and work two volunteer shifts per student for the 2011-12 season, or donate in lieu of volunteering. When you choose to volunteer, then you agree to sign up for volunteer jobs (instructions will be given at the mandatory meeting). If you have agreed to volunteer but do not sign up for volunteer jobs, the team will place you where you are needed at games or SCM will bill you the appropriate opt out fee. It will be your responsibility to rearrange if that placement conflicts with your schedule.

Parental Commitment: (Please make one choice. If opting out (option #2 or #3), add amount to your sports fee payment on your check.

One parent of every student enrolled in After School Sports will either:

- ___ 1) Volunteer two hours at the concession stand in the following manner:
 - a. two separate home game days for one hour each day, or
 - b. one home game day for two hours,
- OR ___ 2) donate \$25.00 in lieu of each hour not volunteered, enclose \$50.00 check w/this form
- OR ___ 3) a combination of both (1 hour volunteered, and \$25.00 in lieu of one hour worked) enclose \$25.00 check w/this form

Uniforms will be provided by the school and returned to the school. There will be a \$50 charge for all uniforms not turned in at the end of the season. For practice students must have appropriate, comfortable t-shirt, shorts and shoes.

Transportation to and from games is the responsibility of the parents. Car pools are encouraged and a Team Parent will help coordinate. **All drivers must have Virtus training documentation, driver's license, current car insurance and signed Volunteer Code of Conduct form on file at the school.**

Games begin at 4:30. "C" team plays first (6th level and below are eligible), then Junior Varsity (7th level and below are eligible), then Varsity games are played last (8th level and below are eligible). We may not always have all three teams, nor will they always all play on game days.
