**Parent Volunteer Positions:** *Fall After School Sports* at SCM are parent-run organizations that require each family to attend the **mandatory meeting on Wednesday, August 17<sup>th</sup> @ 5:00-5:30 and work two volunteer shifts per student** for the 2011 season, or donate in lieu of volunteering. When you choose to volunteer, then you agree to sign up for volunteer jobs (instructions will be given at the mandatory meeting). If you have agreed to volunteer but do not sign up for volunteer jobs, the team will place you where you are needed at games or SCM will bill you the appropriate opt out fee. It will be your responsibility to rearrange if that placement conflicts with your schedule.

One parent of every student enrolled in After School Sports will either:

**Uniforms** will be provided by the school and returned to the school. There will be a \$50 charge for all uniforms not turned in at the end of the season. Students must bring shin guards, **black** shorts and soccer shoes to their first practice.

**Transportation** to and from games is the responsibility of the parents. Car pools are encouraged and a Team Parent will help coordinate. **All drivers must have Virtus training, driver's license, current car insurance and signed Volunteer Code of Conduct form on file at the school.**

**Games** are usually on Mon. and Wed. (unless a make-up game is needed) and begin at 4:30pm and usually end close to 6:00pm.
